He assured Council Members that there was no intention to close the Safer Neighbourhood Team but did state that he considered the premises used by the Police at Tibshelf Motorway Service Area were unsuitable and that enquiries were ongoing to find a more suitable location.

Inspector Burns did advise Council Members that PC Lorna Evans would be moving elsewhere within the Chesterfield Division and that her replacement would be PC Christopher Grant. Inspector Burns also assured Council Members that PC Evans would not be lost to the Councils area completely as she would be in, what was regarded as a reactive role, part of a mobile response team.

HIGHWAYS

The Clerk reported for information receipt of an email from the Traffic and Safety Service, Derbyshire County Council advising the Council that the speed humps located at New Lane and Hilcote Lane, Hilcote would not be removed.

In response to questions from a number of Council Members Councillor C R Moesby, in his capacity as County Councillor agreed to speak with Officers from the Highways Department, Derbyshire County Council with regard to further traffic surveys being carried out on traffic movement at New Lane and Hilcote Lane, Hilcote.

The Clerk also reported for information that Severn Trent Water had applied for an extension to the temporary road closure Huthwaite Lane/Blackwell Road, Blackwell to the 30 June 2015.

Following a request from Councillor R J Sainsbury, Councillor C R Moesby in his capacity as County Councillor agreed to speak with the Highways Department, Derbyshire County Council, with regard to the gully outside 159 Alfreton Road, Newton being cleared etc.

PLAYING FIELDS

The Chairman reported on behalf of the Newton Community Association that a plan had been received from Groundwork Creswell with regard to Phase One of the installation of new play equipment at the Councils Charnwood Crescent Playing Field.

A copy of the plan was circulated to all Members and concerns were expressed with regard to the timber construction of the equipment and possible vandalism. The Chairman agreed to discuss the matter further with Groundwork Creswell.

The Clerk reported receipt of an email from the Assistant Contracts Manager, Groundwork Creswell, stating that the solar lighting company were due to be at Tibshelf Road Playing Fields, Westhouses on 29/30 April but had postponed this as they were unable to hire a cherry picker. An ultimatum to the contractors by Groundwork Creswell giving them until 22 May 2015 to restore the lighting to full working order and that Groundwork Creswell had been advised that the contractors would be able to resolve the situation within that timeframe.

Several Council Members expressed their concern with regard to the length of time that it had taken to repair the solar lighting and it was

RESOLVED that the Clerk write to Assistant Contracts Manager, Groundwork Creswell expressing:

1. Council Members concerns.
2. That in the event of the work not being carried out within the timeframe specified then suitable reimbursement be sought.

The Clerk also reported for information receipt of an email from Brabners Solicitors advising that the Charity Commission had responded to them to the effect that they were asking the current Trustees various questions with regard to the land at Pasture Lane, Hilcote and that they were taking up the proposal for transfer of the trusteeship.
