## 2/2014 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors D G B Bullock, I G Cox and C R Moesby.

# 3/2014 <u>DISCLOSABLE PECUNIARY INTEREST/CODE OF</u> CONDUCT

The Chairman reminded Council members to declare the existence and nature of any disclosable pecuniary interest they had in subsequent Agenda items in accordance with the Parish Councils code of Conduct. Interest that became apparent at a later stage in the proceedings could be declared at that time.

#### 4/2014 PUBLIC SPEAKING

**Mr G Heaseman, Newton** circulated a copy of a letter of objection to the proposed planning development by Wheeldon Brothers Limited for a further 45 dwellings situated at Thurgarton Way, Newton. Mr Heaseman explained to Council Members in a very coherent manner his reasons for objecting to the proposals and Council Members were fully supportive of him.

Following comments by various members of the Council with regard to the possible development, it was agreed that the

Clerk write to the Planning Officer, Bolsover District Council enclosing a copy of the letter written by Mr Heaseman.

**Mr B Clarkson, Blackwell** advised Council Members that the Road Sign at the junction of Fordbridge Lane/Primrose Hill, Blackwell had been damaged. It was agreed the Clerk write to the Highways Department, Derbyshire County Council requesting that the damaged sign be replaced.

# 5/2014 POLICE MATTERS

Council Members noted that no Police Officer was in attendance.

## 6/2014 COUNTY COUNCILLOR C R MOESBY

The Clerk advised Council Members, that due to illness, County Councillor C R Moesby was unable to attend the Meeting.

#### 7/2014 **MINUTES**

The Minutes of the Council Meeting held on 3 March 2014 were approved and signed as a correct record.

## 8/2014 CONFIDENTIAL ITEMS

There were no confidential items.

# 9/2014 CHAIRMANS ANNOUNCEMENTS

Following a brief report from the Chairman with regard to the Code of Conduct.

**RESOLVED** that the Blackwell Parish Council resolves that the wording of the General Conduct Agreement be included in its Code of Conduct in order to bring that Code of Conduct in to line with that adopted by Bolsover District Council (Minute 289/2013 refers).

Following a request from the Chairman, Councillor L Walker acknowledged that he had in fact received a copy of the Councils Standing Orders.

The Clerk advised Council Members that since the last Meeting of the Council held on 3 March 2014 a Freedom of Information request had been received from a resident with regard to having a copy of the Accounts for Payment and also copies of the individual invoices.

The Clerk further commented that he had been in conversation with the Information Commissioner who had advised him that as the resident concerned had been noted at the Council Meeting on 3 March 2014 to peruse all the Invoices presented for payment in accordance with the Freedom of Information Act (Section 22) there was no requirement on the Councils part to provide the resident concerned with individual copies of the Invoices.

Councillor L Walker claimed that the Clerk had not, at the Meeting on 3 March 2014 presented the Invoices for payment and Councillor Walker was roundly criticised by Council Members that the Clerk had in fact provided copies of the Invoices for payment.

It was further agreed, following a suggestion from the Clerk, that should any further requests be received under the Terms and Conditions of the Freedom of Information Act 2000, these would be referred to the Vice Chairman of the Council, Councillor I J A Newham for him to record and then pass to the Clerk to respond.

# 10/2014 ALLOTMENTS

The Chairman reported for information that a complaint had been received from a resident of Sherwood Street, Newton with regard to bonfires that had been lit at the Councils Littlemoor Lane Allotment Site.

The Chairman further commented that the complaint would be referred to the Annual General Meeting of the Allotment Holders Association to be held on 29 April 2014 and that a reminder would be sent to all Allotment Holders of the Tenancy Conditions with regard to bonfires.

The Clerk reported for information that the Memorial Seat in respect of the late Councillor Walter (Sam) Haynes had been received and that the location of the Seat at the Councils Littlemoor Lane Allotments was to be determined.

The Clerk also reported for information receipt of a letter from the Senior Principle Solicitor, Bolsover District Council advising that he had written to the owner of 60 The Ridge, Blackwell advising him that once the Council (Bolsover District Council) had sold the land where 60 The Ridge was now situated it would have passed on the Boundary Fence responsibilities to the new owner.

#### 11/2014 **HIGHWAYS**

The Clerk reported receipt of a letter from the Project Engineer, Highways Department, Nottinghamshire County Council advising him that the Parish Councils objections to a proposed 7.5 tonne environmental weight limit at Chesterfield Road, Huthwaite had been considered at a Meeting of the Transport and Highways Committee, Nottinghamshire County Council on 11 September 2013 who had resolved to over rule the objection and it considered that the route through Hilcote, and Tibshelf carrying a "B" classification was more suitable than unclassified Chesterfield Road for carrying heavy traffic to and from the Tibshelf Industrial Estate. The order would come into effect on 31 March 2014. It was further noted that the Environmental Weight Limit did not cover entirely Chesterfield Road, Huthwaite but only to its junction with Newtonwood Lane, Council Members considered this to be most unsatisfactory.

The Clerk further reported that he had spoken with the Highways Engineer. Derbyshire County Council who had advised him that the County Council had objected to the proposals by Nottinghamshire County Council but had been over ruled.

**RESOLVED** that the Clerk write to the Highways Engineer, Derbyshire County Council expressing the Councils concern with regard to the attitude taken by Nottinghamshire County Council in dealing with this particular objection and it was further agreed that the Cabinet Member responsible for Transport at Derbyshire County Council also be informed.

The Clerk further reported receipt of a letter from the Highways Department, Derbyshire County Council advising that the recent severe winter, wet winter weather had caused extensive damage to the County's roads and that the County Council had taken action to mend as many pot holes as quickly as possible. Road Workers had been working extra hours to help fix the backlog and external contractors had also been brought in 7600 reports about pot holes in the current year had been received compared 5,200 during the same period last year. Progress was being made but it would take time to sort it out.

## 12/2014 PLAYING FIELDS

The Clerk reported receipt of a letter from the Street Scene Co-ordinator. Bolsover District Council giving a quotation for a Grounds Maintenance Contract (grass cutting) at the Councils various Playing Fields in the sum of £3475.15 plus VAT. Following a short discussion

**RESOLVED** that the Quotation received from Bolsover District Council with regard to grass cutting at the Councils Playing Fields in the sum of £3475.15 plus VAT be accepted.

Councillors Mrs C Munks and A F Tomlinson declared a personal interest in the aforegoing item and took no part in the discussion and decision thereon.

The Chairman reported for information that a Meeting with representatives of Groundwork Creswell, Mansfield and Ashfield with regard to the provision of new Play Equipment at Charnwood Crescent Playing Field, Newton was being organised and it was anticipated that a report would be submitted to a future Meeting of the Council.

Councillor R A Poulter advised Council Members of £750 Match Funding to be provided by Sporting Hearts for the Bolsover District Council Streets Sports Diversionary Out Reach Programme 2014.

Councillors expressed their appreciation of Councillor Poulters' action as the additional funding would provide a further ten additional sessions.

**RESOLVED** that Councillor R A Poulter be thanked for his work in relation to the Match Funding for the Sports Diversionary Out Reach Programme 2014.

Councillor R A Poulter took no part in the decision thereon.

#### **13/2014 FOOTPATHS**

Councillor I J A Newham circulated a photograph of what was suspected clinical waste had been dumped on Network Rail land at Westhouses.

**RESOLVED** that the Clerk, as a matter of urgency, contact Network Rail with regard to the removal of the possible clinical waste that had been deposited on Network Rail land at Westhouses.

Councillor B Stocks advised Council Members of a letter that he had received from a resident of Fairfield Avenue, Hilcote with regard to Japanese Knotweed on Derbyshire County Council owned land adjacent to the residents' property.

**RESOLVED** the Clerk write to the Environmental Services Section, Derbyshire County Council, requesting urgent attention

be given the complaint from the resident of Fairfield Avenue, Hilcote, with regard to Japanese Knotweed.

Councillor Stocks further advised Council Members that the Hilcote Environmental and Leisure Project Group had been in negotiation with a local farmer and had acquired an area of land at the junction of Pasture Lane, New Lane, Hilcote and that this would be used for the planting of a suitable fir tree in time for the Christmas 2014 celebrations.

Councillor Mrs P R Wilkinson expressed concerns with regard to dog fouling along the footpath between Littlemoor Lane/Charnwood Crescent, Newton.

**RESOLVED** the Clerk write to the Dog Warden, Bolsover District Council requesting that urgent attention be given to this particular complaint.

Several Council Members commented with regard to the stone wall adjacent to the old vicarage, Church Hill, Old Blackwell, being structurally unsafe.

**RESOLVED** the Clerk write to the Engineer, Bolsover District Council requesting that an urgent inspection be carried out of the stone wall adjacent to the old vicarage, Church Hill, Old Blackwell as soon as possible.

## 14/2014 **ACCOUNTS**

A Work Shop had also taken place to monitor activities of Parish and Town Councils to measure contributions to the District Councils Sustainable Communities Strategy.
