## **PUBLIC SPEAKING (20 MINUTES)**

**Mr and Mrs A Boden, Westhouses** advised Council Members of their concerns with regard to motorists speeding along Alfreton Road, Westhouses and asked if Police action could be taken to try and resolve the situation.

It was agreed that the Clerk contact PCSO Paul Brownlee with regard to the possibility of a Speed Watch operation being carried out at the given location but also to involve the Westhouses Residents Action Group.

It was further agreed that the Clerk contact County Councillor Clive Moesby with a request that a Traffic Survey be carried out at Alfreton Road, Westhouses.

**Mr B Clarkson, Blackwell** advised Council Members that a number of trees adjacent to Woburn House, Blackwell had been cut down and asked if the tree stumps could be removed.

It was agreed that the Clerk write to the Street Maintenance Officer, Bolsover District Council, requesting that the tree stumps be removed.

**Mr L Walker, Hilcote** advised Council Members that he considered that the Minutes of the Council Meeting held on 7 September 2015 were incorrect.

When asked by the Chairman to clarify his comments, Mr Walker said that with regard to Minute 113/2015 Councillor A Naylor had taken no action with regard to Mr Walker's complaint about a cracked grate outside his property at Hilcote Lane, Hilcote.

Councillor Naylor assured Council Members that action had been taken and the Clerk was able to report the number of e-mails that had passed between Councillor Naylor, himself and County Councillor Clive Moesby with regard to urgent repairs being carried out to the grate at Hilcote Lane.

**Councillor T J Gascoyne** gave a comprehensive overview of the Summer Sports Coaching Programme 2015 which was as follows:

Councillor Gascoyne asked if the Council was interested in running a similar programme in the future and if so, he could possibly rethink his sports schedule to increase attendance over every session.

Members of the Council remarked what an excellent job Councillor Gascoyne and his colleagues had done with regard to the Summer Sports Programme and it was agreed that a Programme be developed for the Summer 2016 and appropriate budget be set at the Precept Meeting to be held in January 2016.

**PLAYING FIELDS**

The Clerk reported on his conversation with Mr S Hudson, Finance Director, CISWO with regard to the land at Pasture Lane, Hilcote and of the Clerks request that the transfer of trusteeship of the land be expedited without further delay.

The Chairman reported that Groundwork Creswell had received a revised quotation from Crestra Limited for the installation of new Play Equipment (Phase 1) at Charnwood Crescent Playing Field, Newton in the sum of £31961.00 with design fees from Groundwork Creswell at £3995.12p giving a total project cost of £35956.12p . This was for the project as originally provided for but without the fence and the mounds.

The Chairman further reported that Groundwork Creswell had also drawn up a plan for further development in one or more phases to go out to tender as soon as the Parish Council give their approval. This would be on the basis for an attempt to obtain further external funding.

### **RESOLVED**

1. Cresta Limited is instructed to commence work on Phase 1 as soon as possible.
2. Groundwork Creswell obtain quotations for the work in later phases as the basis for seeking funding.

The Chairman further reported that Richard Walker, the Councils Parish Caretaker, had an appointment with his local GP on 7 October 2015 regarding the possibility of returning to work.

Council Members noted that Councillor Gascoyne had already provided his report with regard to the Summer Sports Programme and this had been discussed in the Public Speaking section of the Council Meeting.

**RESOLVED**

That the Clerk contact suitable contractors with regard to issues wanted by disabled users of the Councils Blackwell Community Centre.

The Clerk reported he had received a telephone call from a local resident requesting use of the Councils Newton Community Centre for a family Christmas Dinner at Newton Community Centre on 25 December 2015 and that he had also spoken with Councillor D G B Bullock who had indicated that he had no problems with regard to opening and closing the Community Centre on that day.

**RESOLVED** that the hire of Newton Community Centre on Christmas Day, 25 December 2015, to a local resident be approved.

Councillor B Stocks advised Council Members that the mosaic currently affixed to the wall of the now closed Blackwell Methodist Church had to be removed without delay. It had been provisionally agreed that the mosaic be attached to the wall of the Hilcote Miners Welfare and Community Centre but local residents felt that it might be a target for vandalism.

Councillor Stocks advised Council Members that he had spoken with the current owner the former Hilcote Arms Public House, Hilcote Lane Hilcote who had indicated that he was in agreement for the Mosaic to be affixed to the side wall of his property and would accept responsibility for its safety.

The cost of removing the mosaic from the Methodist Church to its new location was £300.

Council Members were in agreement with this.

**RESOLVED** that the removal charge and re fixing of the Mosaic in the sum of £300 be approved.
