PUBLIC SPEAKING (20 MINUTES)

Mr B Price, Hilcote, referred to Minute 97/2015 with regard to a request from the local Council Member for consideration to be given by Derbyshire County Council for a 20 mph speed limit to be imposed installed at Central Drive Blackwell. Mr Price asked if there had been any fatalities on this particular stretch of road and he was advised that there had not been any.

Councillor C R Moesby in his capacity as County Councillor advised Mr Price that Derbyshire County Council was about to consult on the 20 mph speed limit within the village of Hadfield, Glossop, and in conjunction with Derbyshire Constabulary monitor the scheme over a twelve month period following its implementation on-street. Therefore the County Council would not be promoting any further 20 mph speed limits until the impact and effectiveness of the proposed scheme in Hadfield had been accurately assessed.

Mr L Walker, Hilcote advised Council Members that despite a request to Councillor A Naylor to forward Mr Walker's complaint with regard a

collapsed drain outside his property at Hilcote Lane, Hilcote, and Councillor Naylor had taken no action.

Councillor Naylor advised Mr Walker that he had in fact contacted the Clerk with regard to Mr Walker's request who in turn had been in contact with the Highways Department, Derbyshire County Council and repair work had been swiftly carried out at Hilcote Lane, Hilcote.

CHAIRMAN'S ANNOUNCEMENTS

The Chairman reported for information:-

ALLOTMENTS

The Chairman reported for information

1. The next Meeting of the Allotment Committee would be held on 28 September 2015.

2. A complaint had been made by a resident of Sherwood Street, Newton with regard to a fire on the Littlemoor Lane Allotments; the allotment holder had been interviewed and apologised for causing a nuisance to the resident of Sherwood Street. The Chairman said that he would raise this matter at the next Committee meeting and request that a reminder of the rules concerning bonfires be issued.

Councillor I G Cox requested that the Parish Caretaker trim round the litter bin on the Littlemoor Lane Allotments.

HIGHWAYS

The Clerk reported:

1. Receipt of an email from the Traffic and Safety Service Officer, Derbyshire County Council with regard to the Councils request for a 20 mph limit at Central Drive, Blackwell, and he had responded that the area around Central Drive was residential and there had been no reported personal injury collisions within the last five years and it was

unlikely that a 20 mph zone would be given priority for future funding. In respect of Central Drive specifically it was evident that it is subject to heavy on-road parking due to a significant number of properties not having access to off road parking provision in the form of a driveway or garage although it appeared an informal arrangement was in place in that vehicles all park on the left hand side of the road as look up from the junction with Alfreton Road, Blackwell.

2. Receipt of an email from the Traffic and Safety Service Officer, Derbyshire County Council, with regard to various traffic issues at Hilcote Lane, Hilcote. The County Council based on the collision history for Hilcote Lane and New Lane have no intention of removing the traffic calming features at this location, they are a contributory factor in the roads very good safety record. The residents of Hilcote had received detailed correspondence in the past with regard to noise and pollution concerns from the Director of Public Health at the County Council.

In respect of the installation of a vehicle activated sign for New Lane, this had again been addressed in previous correspondence to the resident concerned.

The Traffic and Safety Service Officer concluded his email stating that the resident's enquiry with regard to the installation of a vehicle activated sign within the curtilage of his property would require appropriate planning consent from Bolsover District Council.

3. Temporary road closure Tibshelf Road, Westhouses, 7 September 2015 to 10 September 2015 between 23.00hours and 0630 hours each night for repairs to the brickwork on the rail bridge

4. Request for a traffic priority sign at the bridge over the Shirland Brook, Park Lane, Westhouses.

RESOLVED that the Clerk write to the Highways Department, Derbyshire County Council requesting that consideration be given to providing a traffic priority sign at the bridge over the Shirland Brook at Park Lane, Westhouses.

Councillor C R Moesby, in his capacity as County Councillor declared a personal interest in the foregoing items and took no part in the discussion and decision thereon.

Councillor T J Gascoyne advised Council Members that a fire had occurred at a Council house on Deamon Street, Blackwell and due to inconsiderate parking by a number of residents with motor vehicles, the Fire Brigade had difficulty getting to the property.

Councillor Gascoyne suggested that consideration be given by Bolsover District Council to turning the traffic island on Deamon Street into a parking area to try and minimize traffic issues.

RESOLVED that the Clerk write to the Director of Housing, Bolsover District Council requesting that consideration be given to the traffic island at Deamon Street, Blackwell be turned in to a parking area.

Councillor R J Sainsbury advised Council Members that during a recent rain storm the drain adjacent to 157 Alfreton Road, Newton was again blocked.

County Councillor C R Moesby, in his capacity as County Councillor, said he would report this matter to the appropriate Officer at Derbyshire County Council

PLAYING FIELDS

The Chairman and Councillor R A Poulter reported for information that the Solar Lighting at Tibshelf Road Playing Field Westhouses was now functioning satisfactorily

The Clerk reported that he had been in contact with Solicitors acting on behalf of CISWO with regard to the land at Pasture Lane, Hilcote who in turn had been in contact with the Charity Commission to try to progress the trusteeship of the land.

The Chairman reported, on behalf of Newton Community Association, that further estimates had been received with regard to the Play Equipment proposed for Charnwood Crescent, Playing Field Newton replacing wood with steel and estimates were considerably in excess of £36,000 currently available.

Council Members suggested that a smaller project be implemented at Charnwood Crescent Playing Field to keep within the budget of £36,000.

It was further agreed the Clerk speak with the Leisure Officer, Mr M Connelly at Bolsover District Council with regard to other contractors.

The Clerk reported for information that the Councils Part Time Parish Caretaker, Mr R Walker was being admitted to hospital on 10 September 2015 and would be away from his duties for approximately two/six weeks.

It was also agreed that Mr Walker be requested to clear the weeds around the War Memorial at Newton, cut the hedge behind the bus shelter, Main Street, Newton and empty the litter bin at Littlemoor Lane Allotments, Newton.

If, however, the Council were prepared to enter into a further long term agreement with Came and Company to 30th September 2018 the premium would be reduced to £7600.14p

RESOLVED that the insurance quotation received from Came and Company for a long term agreement until 30th September 2018 in the sum of £7600,14p be accepted subject to the Clerk securing three additional quotes.

The Clerk also reported receipt of an email from the Information Commissioners Office advising that a parishioner had requested under the Freedom of Information Act 2000 copies of all receipts and payments from April 2014 to the present day, and the Clerk had advised the Information Commissioner that the request submitted by the parishioner that the Council intended to refuse this request on the basis that it would be too costly to provide and the relevant part of the Freedom of Information Act 2000 that provides an exclusion in these circumstances was Section 12.

The parishioner had also requested information be provided on salaries paid to employees of the Council and the Clerk advised the Information Commissioner that this information would not be provided to the parishioner concerned in accordance Section 40 of the Freedom of Information Act 2000.

RESOLVED the Clerk be authorised to write to the parishioner requesting the foregoing information and outlining the reasons for refusal.

The Clerk reported receipt of a letter from Councillor I G Cox suggesting the Council Plant an Oak Tree at the grassed area Littlemoor Lane Allotments to commemorate the Queen becoming the longest serving monarch in English history and also the centenary of the First World War.

Councillor D G B Bullock advised Council Members that he would be removing an Oak Tree from his garden and would donate to the Council to be planted at the Littlemoor Lane Allotments.

1. Approval be given for an Oak Tree to be planted at the grassed area Littlemoor Lane Allotments.
